EMERGENCY PROCEDURES

24 HOUR ADVICE IN AN EMERGENCY ONLY 0800 243 622

IF THIS HAPPENS	DO THIS
Tanker/Vehicle Accident	Switch off engine and electrical equipment. Keep people away, warn other traffic. Check for spills, leaks. Call the emergency services: Dial 111
Spill or leak	Wear PVC overalls, chemical resistant gloves, facemask or goggles. Prevent further spillage. Adsorb spilled product and place in sealable container for disposal. Wash down affected area with water plus detergent. Absorb and collect washings and place in the same sealable container for disposal. Seek advice from the local authority regarding disposal
Fire	Call the Fire Service: Dial 111. Wear full chemical resistant clothing and self-contained breathing apparatus. May release oxides of carbon and nitrogen in case of fire.

FIRST AID

24 HOUR ADVICE IN A FIRST AID EMERGENCY 0800 POISON (0800 764 766)

If Swallowed:	Immediately call the National Poisons Centre (0800 764 766) or a doctor for advice. Do NOT induce vomiting unless told to do so by the National Poisons Centre or a doctor. Have person sip a glass of water if conscious and able to swallow
If in Eyes:	Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Call the National Poisons Centre or a doctor for advice.
If on Skin:	Wash with plenty of soap and water. Take off contaminated clothing and wash before reuse.
If Inhaled:	Move person to fresh air and keep at rest in a position comfortable for breathing. Call the National Poisons Centre or doctor if the person feels unwell. If person is not breathing dial 111 for an ambulance, then give artificial respiration

Storage: Store securely in original container, tightly closed and in a dry, cool, well ventilated area away from foodstuffs.
