**EMERGENCY PROCEDURES**

**24 HOUR ADVICE IN AN EMERGENCY ONLY 0800 243 622**

**IF THIS HAPPENS DO THIS**

<b>Tanker/Vehicle Accident</b>	Switch off engine and electrical equipment. Keep people away, warn other traffic. Check for spills, leaks. <b>Call the emergency services: Dial 111</b>
<b>Spill or leak</b>	Wear protective clothing. Contain spillage. Prevent chemical contaminating drains or watercourses by activating emergency shut-off valves or using bunding. Inform appropriate authorities immediately if spill enters waterways or sewers. Prevent chemical contaminating soil.
<b>Fire</b>	<b>Call the Fire Service: Dial 111.</b> Wear full chemical resistant clothing and self-contained breathing apparatus. May release oxides of carbon and nitrogen in case of fire.

**FIRST AID**

**24 HOUR ADVICE IN A FIRST AID EMERGENCY 0800 POISON (0800 764 766)**

<b>If Swallowed:</b>	Immediately call the National Poisons Centre (0800 764 766) or a doctor for advice. Do NOT induce vomiting unless told to do so by the National Poisons Centre or a doctor. Have person sip a glass of water if conscious and able to swallow
<b>If in Eyes:</b>	Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Call the National Poisons Centre or a doctor for advice.
<b>If on Skin:</b>	Wash with plenty of soap and water. If skin irritation occurs get medical attention. Take off contaminated clothing and wash before reuse.
<b>If Inhaled:</b>	Move person to fresh air and keep at rest in a position comfortable for breathing. Call the National Poisons Centre or doctor if the person feels unwell. If person is not breathing dial 111 for an ambulance, then give artificial respiration
