• Contact with green parts (including immature bark) of desirable plants, may cause damage to occur.
• Do NOT apply if rainfall expected within 2 hours of application may wash **Glypho Free Weedkiller** off the foliage, and within 6 hours will reduce effectiveness so that re-treatment may be necessary.
• Do NOT mow or cultivate after treatment until weeds start to die off.
• Avoid contamination of any water source with product or empty container.

HOW IT WORKS: Contains no glyphosate. **Glypho Free Weedkiller** is a non-selective herbicide which is active against a wide range of broadleaf and grass weeds in non-cropland areas. **Glypho Free Weedkiller** is absorbed into the foliage and green stems of actively growing plants. It is inactive in soil and is not translocated as an active herbicide, so thorough coverage of target weeds is essential for good results. The visual effects of treatment will become evident more rapidly under ideal growing conditions, generally within 3-10 days. **Glypho Free Weedkiller** will not completely control mature weeds with well-developed tap roots or underground storage organs: some re-growth may occur following treatment.

MIXING INSTRUCTIONS: Shake the container well before use. Add about half of the required water to the spray tank, then add the required amount of product. Mix and add the remaining water. It is best practice to use separate equipment for applying herbicides.

COMPATIBILITY: **Glypho Free Weedkiller** is compatible with most commonly used residual herbicides and may be mixed with residual herbicides for long-term weed control.

DIRECTIONS FOR USE

USE	RATE	COMMENTS
Non-cropland areas	10 mL to 1 litre water.	Apply in a drenching spray to the point of run-off. Do NOT exceed 100mL of diluted spray solution per square metre. This may be applied a maximum of twice per year with a minimum interval of 90 days between applications.

EQUIPMENT CLEANING: After application, clean equipment thoroughly with several flushes of water. Dispose of washings carefully.

PERSONAL PROTECTION: Obtain special instructions before use.

Do not handle until all safety have been read and understood.

Avoid contact with skin and eyes. Do not breathe spray mist. Wear protective clothing, gloves, eye protection and respiratory protection. Do not eat drink or smoke when handling. Wash hands after use and clean protective clothing.

FIRST AID: If exposed or concerned call a doctor or contact the National Poisons Centre (0800 764 766). If medical advice is needed, have product label or container at hand.

IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses if present and easy to do. Continue rinsing. If eye irritation persists, get medical advice.

IF ON SKIN: Take off contaminated clothing. Wash skin with plenty of soap and water. If irritation persists, get medical advice. Wash contaminated clothing before reuse.

IF SWALLOWED: Rinse mouth. Do NOT induce vomiting. Get medical advice if you feel unwell.

STORAGE: Keep out of reach of children. Store in the tightly closed original container, in a cool, dry and locked location and away from foodstuffs. Shelf life two years from the date of manufacture.

DISPOSAL: Dispose of product by using as per label directions or at an approved landfill. Triple rinse empty container adding washings to spray mix. Dispose of the empty rinsed container in the rubbish collection. Do not reuse the container for any other purpose.

SPILLAGE: Collect spillage. Absorb spill with inert absorbent and transfer to a labelled suitable container for disposal at an approved landfill.
